- Building & Grounds (John Roberts)
 - o Roof repair
 - Repair is underway and should be done by the close of the week (March 27)
 - Water Softener
 - Purchase option
 - \$4,600 covers installation and first salt fill. We would own the softener system with this purchase
 - Lease Option
 - \$156.72 per month for a 36-month lease
 - \$124.11 per month for a 48-month lease

- \$104.19 per month for a 60-month lease (lease options would include any parts needed for repairs over the life of the lease. This would not include salt or labor charges
- PC believes this would be a wise decision to purchase.
 - Motion to proceed with purchase pending funding. John Fisher motion, Doug Jones Second. Motion passes
 - Action Item: Father Andrew to follow up with potential funding (memorial fund)
- Next items to prioritize is internal cosmetic issues like the ceiling, alter area, etc.
 - Parish Hall area
 - Mold in church ceiling
 - Alter area B&G
